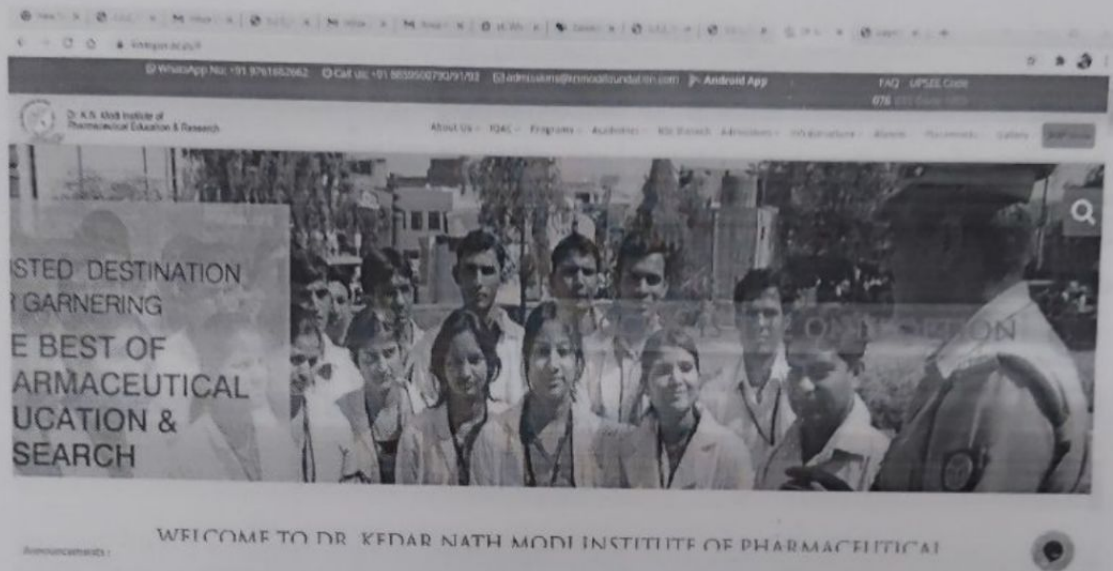
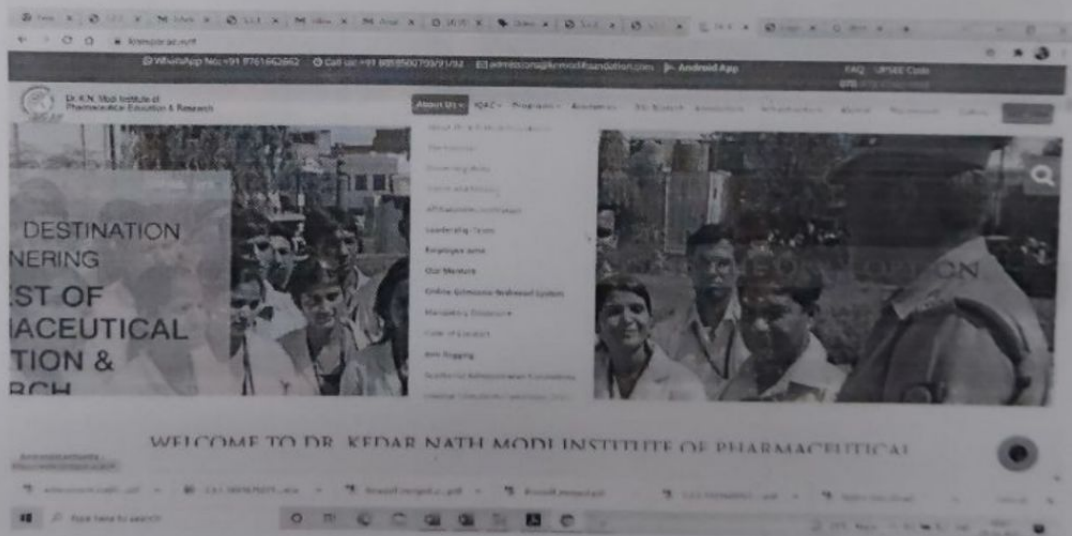

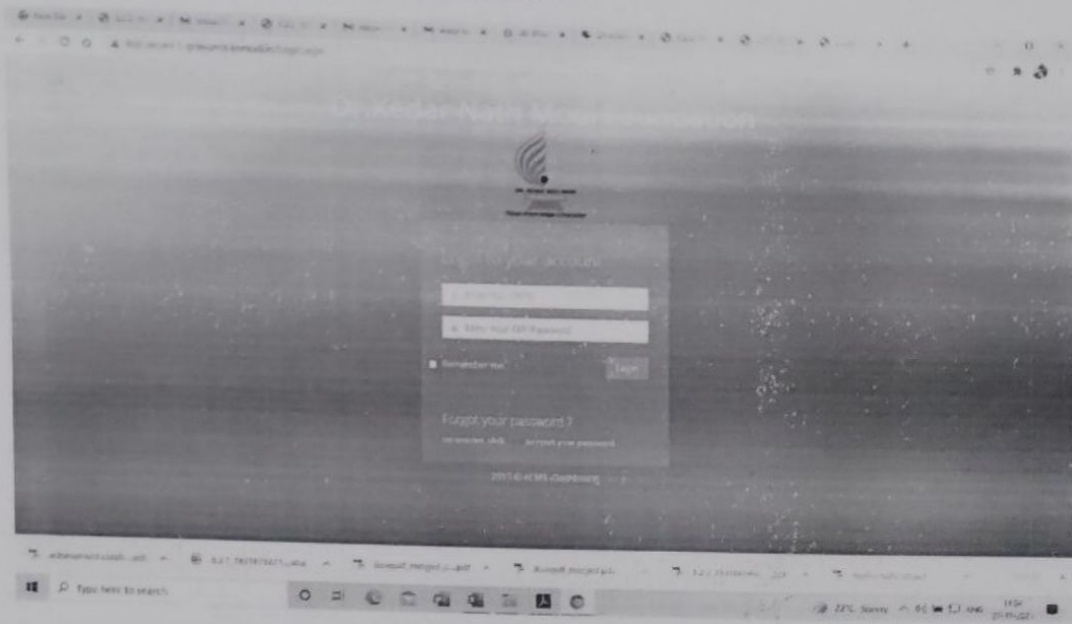
Step-1- Click on the 'About Us' Tab.



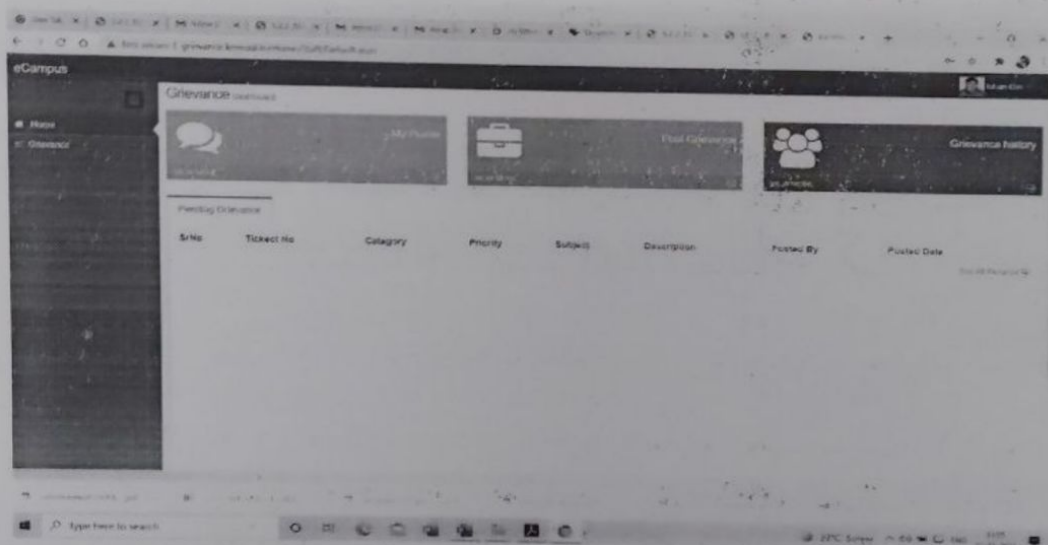
Step-2- Now Click on the 'Online Grievance Redressal System' tab.



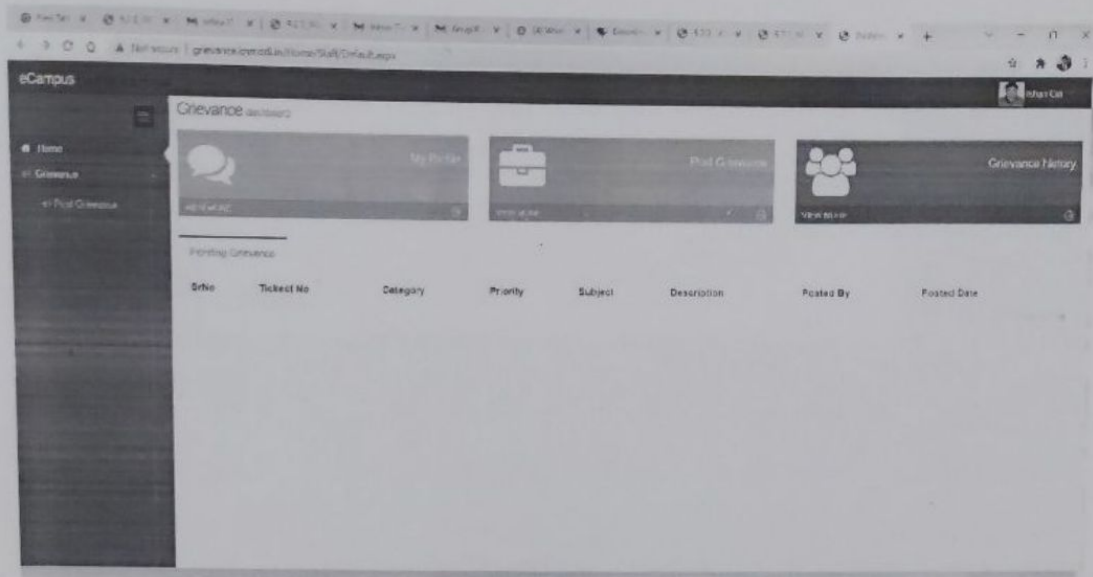
Step-3 – Now enter your college ERP id and password.



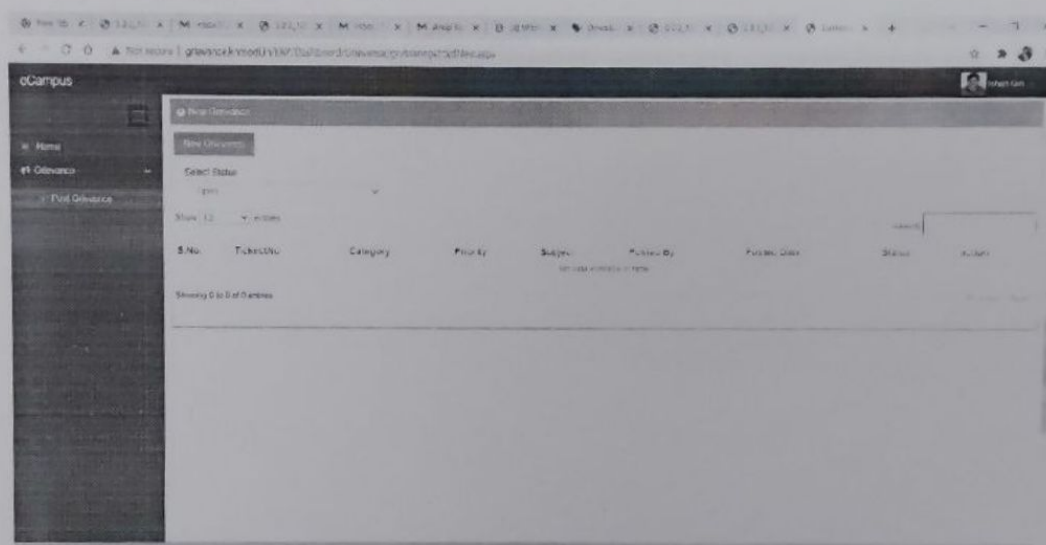
Step 4- Grievance Dashboard is open. Now click on menu tab and then click on the home tab. Then click on the grievance tab.



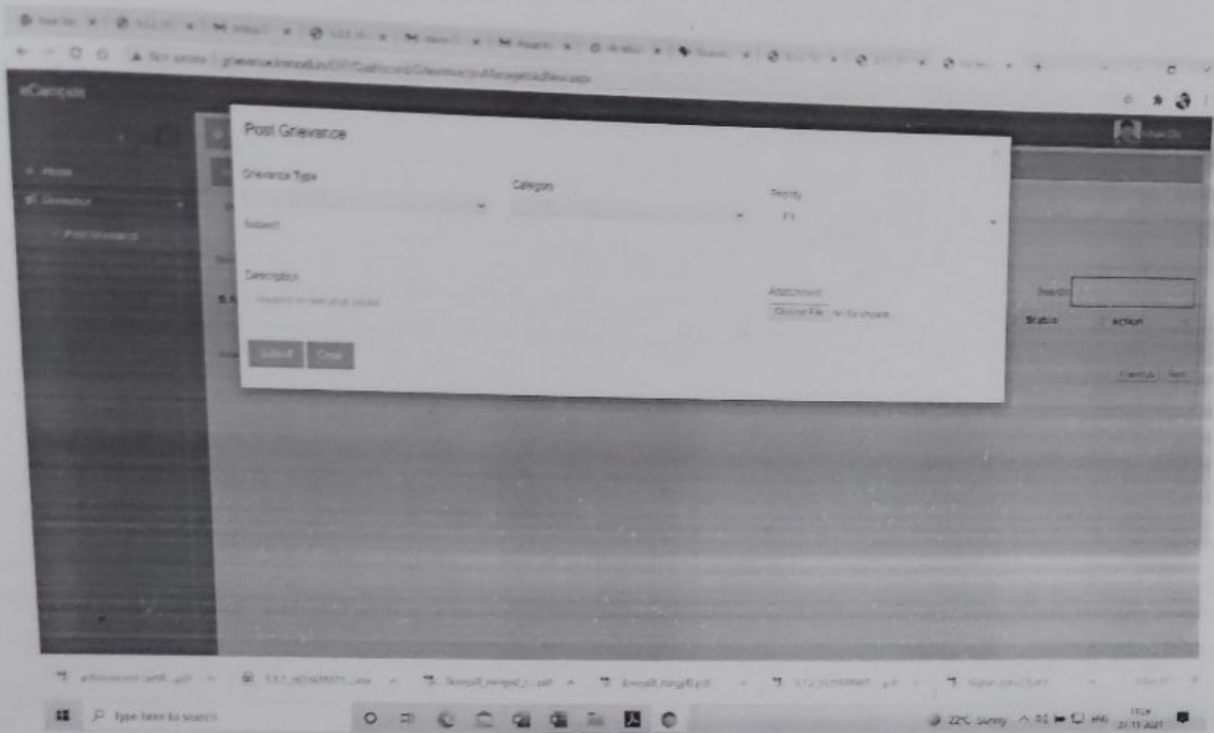
Step-5-Click on the post grievance tab.




